FAITH AND PUBLIC LIFE UPDATES

Speech by Prime Minister on addressing extremism

On 20 July Prime Minister David Cameron made a speech setting out his plans to address extremism. This included: an announcement of a review to be led by Louise Casey to produce "a comprehensive review into boosting opportunity and integration to bring Britain together as one nation" and other plans including:

- Strengthen communications watchdog Ofcom role to take action against foreign TV channels broadcasting extremist messages
- 'Incentivise' schools to become more integrated
- Demand that internet service providers do more to remove extremist material and identify those responsible for it
- Overhaul the strategy to tackle extremism in prisons
- Consult on introducing lifetime anonymity for the victims of forced marriages
- Urge universities to do more to challenge the views of extremist speakers
- Set up a new engagement forum
- Launch a study looking at how extremism spreads

National youth consultation on extremism

Faith Matters and British Muslim Youth launched a National Youth Consultation on 7 July in London, the 10th anniversary of the London bombings. The Consultation will take evidence from youth groups, academics, youth work practitioners and young people, with a view to assessing the accessibility and impact of extremist material on-line on young people. The Consultation will begin work in September and will visit Birmingham, Bristol, Manchester, Leeds and London. Far Right rally moved

A rally against the Shomrim, a Jewish neighbourhood watch group, in Golders Green in Barnet, North London timed for the Sabbath, was later moved, following high levels of concern, by Police order and took place instead in Whitehall.

Significant in the protest against the plans were Golders Green Together and the Barnet Multi Faith Forum. Local inter faith bodies in a number of areas of the UK, together with faith communities, continue to play an important role in seeking to defuse community tensions and tackle bigotry and extreme voices.

Cremation and coroner services

In the Summer Budget, presented on 8 July, Chancellor George Osborne announced that the Government will conduct a review into the size and provision of crematoria facilities to make sure that they are fit for purpose and sensitive to the needs of all users and faiths. This review will be carried out by the Department for Communities and Local Government.

The Chancellor was quoted in a press release from Hindu Forum of Britain of the same day as having said that over the past year, a number of British Hindus and Sikhs had raised with him their concerns about cremation facilities for their communities and told him that often the facilities were not large enough for everyone from the community to pay their respects and did not always pay enough regard to cultural sensitivities.

Separately, the Ministry of Justice will be carrying out a consultation on changes to rules for cremations and a review of the out-of-hours services provided by coroners in England and Wales to make sure they are sensitive to the needs of the whole community, including those whose beliefs require burials to take place quickly. The latter Review follows meetings Justice Secretary Michael Gove has had with faith groups on improving coroner services.

Review of Marriage Law

The Government has asked the Law Commission to conduct a review of the law governing how and where people can marry in England and Wales. The question underlying the review is whether the current law, which has evolved over a long period of time, provides a fair and coherent legal framework for enabling people to marry in a way which meets their needs and wishes while recognising the interests of society and the state in protecting the status of marriage.

The Law Commission has recently begun an initial piece of work to prepare the way for the potential future reform. This includes a preliminary study involving research of domestic and comparative law, and engagement with key stakeholders including faith communities. The aim will be to identify and provide an initial analysis of the issues that need to be addressed in order to develop proposals for the reform of marriage law. It expects to publish its findings by the end of 2015 when, with Government, it will consider next steps, including the possible involvement of the Commission.

The review will not include questions of who can be married; whether or not religious groups should be obliged to solemnize marriages of same sex couples which was recently decided by Parliament; or of the rights or responsibilities which marriage imparts, such as the financial entitlements of surviving spouses or consequences of divorce.

The next Census in England and Wales will be in 2021. As part of the census research programme, the Office for National Statistics (ONS) has launched a public consultation asking users for their views on the topics that the 2021 Census questionnaire might cover. It is encouraging people to respond online to its current proposals. Anyone can take part in this public consultation which closes on Thursday 27 August and users' feedback will inform further research, development of questions, and consultations.

Religion and belief in school – a Westminster Faith Debates report

A Westminster Faith Debates report ‘A New Settlement: Religion and Belief in Schools’ by former Minister Charles Clarke and Professor Linda Woodhead was published in June. 18 policy recommendations are made by them, covering the act of collective worship, the content and formation of the legally required RE curriculum and the operation of faith schools. Among these there are proposals that: the requirement for schools to have an Act of Collective Worship should be abolished; consideration be given to using the phrase ‘Religious and Moral Education’ rather than ‘Religious Education’ in describing this part of the statutory curriculum; and the Religious Education syllabus in county and voluntary controlled schools should no longer be set by a system of locally agreed syllabuses, but be an agreed national syllabus which would have a similar legal status to the requirements of other subjects in the National Curriculum.

It's summer: it must be inter faith cricket!

Inter faith cricket has become something of a phenomenon. 'Imams versus vicars' matches have taken place for some years in Leicester (organised by the St Philips Centre and the Community Football Academy), and Birmingham (Solihull Building Bridges Islamic Initiative). An annual tournament, 'The Bishop's Cup', has taken place between St Albans, Watford and Luton since 2011 when it was set up by the Inter Faith Adviser to the Diocese of St Albans.

There have also been inter faith cricket matches in cities such as Bradford and Leeds and in a number of other areas. For example the seventh annual inter faith cricket tournament recently took place at Boyne Hill Cricket Club in Maidenhead. This was organised by the Windsor and Maidenhead Community Forum and the Guru Nanak Sat Sang Sabha Sikh Temple, in Rutland Road. Faith communities and inter faith engagement - SCJC

Faith communities continue to develop ways to equip their clergy, staff and volunteers to engage with those of other faiths. For example, the Scottish Council of Jewish Communities (www.scojec.org) has recently launched a volunteer training course which aims to help people who wish to represent Judaism in the local community including through working with inter faith groups. The course focuses on particular areas of Jewish life such as festivals, food, the life cycle, as well as information about the Religious and Moral Education syllabus in the Curriculum for Excellence, presentation skills, session planning and preparation, and how to be mindful of each faith and practice at an inter faith event.

- Arts and cultural events
- Faith and food events

This year, why not consider a hands-on social action project – from tree planting to volunteering together in another way that helps the local community. Or hold a discussion about how living well together as people of different faiths and beliefs and how we contribute to our shared society.
