## FAITH AND PUBLIC LIFE UPDATES

### Refugees and migrants – faith and inter faith responses

With Syrian refugees arriving in a number of areas of the UK, faith groups and inter faith bodies are continuing to respond to assist. In Nottingham, for example, the Nottingham Post reports that refugees were warmly welcomed, with faith leaders in the city leading the way. A statement from Christian, Muslim, Jewish, orthodox and liberal groups was released. It begins: "We, the leaders of the faith communities in Nottinghamshire, wish to add our voices, and the voices of the people we serve, to those of good will everywhere who seek to provide compassion and practical help to those most affected by the current refugee crisis. We urge people of faith, and none, to come together to show the best of Nottinghamshire's proud heritage of welcome and care for those who have faced persecution and loss. We welcome those refugees and asylum seekers arriving in our county and pledge to continue to offer them our hospitality and support."

In many other areas help is being given or has been pledged. For example Fife Interfaith Group has written to the Chief Executive of Fife Council to state that its members stand ready to assist with this process in any way they can and that representatives from its various faiths have offered to convene at reception centres to welcome refugees and signpost them to their various faith communities, saying " In doing so we will not only make them feel welcome but will demonstrate to them that religious faiths can live in harmony and offer each other support as we have done since our group was founded ten years ago. There can be no better way of letting these families know that they have truly arrived at a safe haven."

Faith and inter faith groups in a number of towns and cities have also been arranging or providing support for refugees and migrants in Calais. The London Churches Group and Faiths Forum for London arranged a delegation to Calais to see the conditions at the migrant camp on the outskirts of the city. The visit aimed to see how communities in the capital can provide support or assistance for the migrant crisis in Europe.

Churches Together in Britain and Ireland reports that Churches, Church leaders and aid organisations across Britain and Ireland are responding to the refugee crisis by calling on their governments to take action, encouraging donations from church members and providing support where possible, often through partner organisations.

There are, of course, refugee crises in a number of parts of the world and these and other faith and non-faith based agencies such as Sewa International also work to assist in many areas with these and other humanitarian causes.

## **Faith and inter faith response to terrorist attacks in Paris**

On the evening of 13 November a series of coordinated terrorist attacks occurred in Paris, France. The Islamic State of Iraq and the Levant (ISIL) claimed responsibility for these.

In the UK faith and inter faith groups responded with prayers, vigils and statements. Many used already planned Inter Faith Week events to stand together in solidarity and remembrance. ## **Commission on Religion and Belief in British Public Life - report**

The Commission on Religion and Belief in British Public Life, chaired by Baroness Butler-Sloss, published its report on 7 December. The report is entitled 'Living with Difference: Community, Diversity and the Common Good'.

The Commission was convened in 2013 by the Woolf Institute to consider the place and role of religion and belief in contemporary Britain; to consider the significance of emerging trends; and to make recommendations for public life and policy. The report draws on a public consultation process including over 200 submissions, as well as research evidence. It describes the changing religion and belief landscape, before exploring six broad themes. It makes 12 detailed recommendations covering such issues as religion and belief literacy; a curriculum about religion, philosophy and ethics in schools; admissions and employment policies in schools with a religious character; the promotion of opportunities for interreligious and inter-worldview encounter and dialogue; compliance by religious and cultural tribunals with UK standards of gender equality and judicial independence; and counter-terrorism legislation.

## **Government review of the Muslim Brotherhood**

In April 2014 the Prime Minister commissioned an internal review of the Muslim Brotherhood. The main findings were published on 17 October and can be found at <https://www.gov.uk/government/publications/muslim-brotherhood-review-main-findings>.

The statement concludes with the intent that the Government will “keep under review the views that are promoted and activities that are undertaken by Muslim Brotherhood associates in the UK in Arabic as well as English. We will consider whether any action under the Counter Extremism Strategy or as part of our wider work may be appropriate, including action in line with the new engagement policy the Government will develop to ensure central and local government does not inadvertently provide legitimacy or a platform for extremists. We will challenge extremists’ poisonous narratives and promote positive alternatives that show vulnerable people that there are better ways to get on in life”.

## Law Commission Review of marriage law

As noted in the July/August issue of the e-bulletin, in December 2014 the Government asked the Law Commission to conduct a review of the law governing how and where people can marry in England and Wales. The question underlying the Review was whether the current law, which has evolved over a long period of time, provides a fair and coherent legal framework for enabling people to marry.

The Law Commission has carried out an initial piece of work, including a preliminary study involving research of domestic and comparative law, and engagement with key stakeholders, to identify and provide an initial analysis of the issues that need to be addressed in order to develop proposals for the reform of marriage law.

The resulting scoping paper, 'Getting Married' was published on 17 December and can be downloaded from <http://lawcom.gov.uk/project/marriage-law/> together with an executive summary. The next step is for Government to respond to the recommendations for further work.

## Consultation on cremation

The Ministry of Justice has launched a consultation on cremation, which seeks views on proposals for a number of changes to the Cremation (England and Wales) Regulations 2008, and for improving other aspects of cremation practice. In writing the consultation document the Ministry of Justice has worked with the Department of Health, the Department for Environment, Food and Rural Affairs and the Department for Communities and Local Government as well as the Human Tissue Authority and the Welsh and Scottish Governments.

## National Faith Community Representative Bodies meet

A meeting for member National Faith Community Representative Bodies took place in London on 5 November. There was a special focus session on chaplaincy in prisons, with presentations by the Revd Canon Michael Kavanagh, Chaplain-General and Head of Chaplaincy and Faith Services for the National Offender Management Service, and Mr Mohinder Singh Chana, Network of Sikh Organisations and Sikh Chaplaincy Services UK - Area Manager, Yorkshire, Humberside and the North East region. This was the third in a series of FCF sessions looking at multi faith chaplaincy, following earlier sessions on health care chaplaincy and Higher Education chaplaincy.

## Collective Worship and Religious Observance in Schools: An Evaluation of Law and Policy in the UK

The AHRC Research Network on Collective Worship published on 13 November a report entitled 'Collective Worship and Religious Observance in Schools: An Evaluation of Law and Policy in the UK'.

The report aims to stimulate fresh thinking on collective worship and religious observance in schools. It sets out the law and educational concerns relating to each country, and considers the merits of a range of options available to policy makers. While many of the observations made in the report apply to all schools, the report "restricts the majority of its recommendations to schools without a religious character, on the basis that separate and distinct consideration should be given to those schools with a designated religious character".

## RE for Real report

The Faiths & Civil Society Unit at Goldsmiths, University of London published a report on 29 November, with funding from the Culham St Gabriel's Trust, entitled 'RE for Real'. It focuses on RE in Secondary Schools, and highlights broad support for RE among parents, pupils and employers. The report makes a number of recommendations, including – echoing both the report of the Commission on Religion and Belief in British Public Life and Charles Clarke and Linda Woodhead's 'A New Settlement' – development of a national framework for religion and belief learning, and continued investment in training opportunities for teachers, including CPD.

## INTER FAITH PROJECTS, PROGRAMMES AND DEVELOPMENTS

### Inter Faith Week

An amazing range of different kinds of events and projects took place during Inter Faith Week in England, Wales and Northern Ireland – all 400+ of them making a contribution to understanding and cooperation between people of different faiths and beliefs and raising the profile of the contribution that faith groups make to society. It was a Week when the importance of 'living well together' was highlighted including – in the wake of the terrorist attacks in Paris – many raising their voices together to affirm what they value in our shared society and against terrorism and other forces of destruction and division.

The Week saw good media coverage, including a segment on Songs of Praise during Day 1 (also featuring Mitzvah Day), and an extended article in the Huffington Post published toward the end of the Week. A number of community papers and on-line media such as Jewish News and The Asian Today featured the Week. The Week saw considerable use of social media, including a planned campaign running up to the start of the Week. Tweets linked to the Week reached the accounts of over 3.4million unique Twitter users, with over 11million impressions. Facebook activity had a reach of over 42,000 users. A number of bodies ran Twitter campaigns linked to the Week, including Near Neighbours, The Feast, DCLG and Faith Matters.

Mitzvah Day took place on 22 November this year and its events formed an official part of Inter Faith Week in England, Northern Ireland and Wales. As in previous years, many social action projects were run with participants from different faiths, and over 50 'Inter Faith Mitzvah Day' projects were listed on the Inter Faith Week website. ## 'Extending Hand of Friendship' project

An initiative called 'Extending Hand of Friendship' took place during Hanukkah (6 to 14 December). It was an initiative of the Joseph Interfaith Foundation which seeks to build stronger ties between British Jews and Muslims.

The aim of the initiative was "to give the chance to individual Muslims who want to extend their hand of friendship towards the Jewish community through a safe forum". There was a greater than anticipated response to the project which saw over 200 cards sent from Muslims to Jewish synagogues during Hanukkah. The cards were sent online either giving a name or anonymously as a well-wishing Muslim neighbour.

### **'Faiths working together' toolkit**

On 19 November, Near Neighbours and the Inter Faith Network for the UK launched, at the Vauxhall Gardens Community Centre in London, the *Faiths Working Together* toolkit.

Published in Inter Faith Week, the toolkit's aims are to support positive cross-faith engagement for the common good and inter faith understanding and help people to

- reach out and engage with people of different faiths in their local area;
- create a successful project that engages people of different religious backgrounds;
- develop and deepen cross-faith understanding and relationships; and
- support people of different faiths as they engage in social action for the good of their neighbourhoods.

The toolkit includes practical pointers for making contact and for planning and publicising initiatives, as well as advice on key principles to consider, such as the importance of looking for shared values and experiences while working well with difference.

The launch was opened with words from Baroness Eaton, Chairman of Near Neighbours, and the Co-Chairs of the Inter Faith Network for the UK, the Rt Revd Richard Atkinson and

Vivian Wineman. There were presentations from three local projects in Luton and Hounslow followed by discussion of the importance of working together between different faith communities.

### **Lessons from Srebrenica**

Remembering Srebrenica is continuing to take British citizens to Srebrenica as part of its educational visits programme to Bosnia & Herzegovina called 'Lessons from Srebrenica'.

The programme includes learning from the survivors and the mothers of those killed in the genocide in 1995. Remembering Srebrenica arranges all aspects of the four-day visit, including flights, accommodation, guide, transport in Bosnia and food. Participants are asked to make their way to Heathrow and to make a donation to Remembering Srebrenica.

Every participant is asked to make a pledge to do something concrete in the UK on their return to tackle hatred and promote social cohesion. The pledge should help to achieve real change and applications will be based on the strength of each pledge.
